- 1 City Creek Parking(CCP) grants to the above cardholder one (1) parking right in the specified parking facility. Those privileges will become effective on \_\_\_\_\_, \_\_\_\_\_. The term of the agreement to be one month, renewable upon the timely receipt of the prevailing fee to CCP. CCP reserves the right to terminate parking privileges with thirty (30) days written notification to the address provided above. Parking Patron will maintain current address information with CCP to facilitate notifications.
- 2 Parking Patron agrees to pay CCP \$\_\_\_\_\_ for each month period, per parking right, as rental for said parking privilege. Such payment is due on the first day of each calendar month. If payment is not made prior to the due date, the parking access card will be deactivated by the parking system. Reactivation requires full payment at the parking office during business hours. No refunds, credits or allowances will be granted for absence, vacation or other non-use of parking rights.
- 3 CCP reserves the right to adjust the rental rate for said parking right from time to time. Notification will be posted at payment machines and the parking office prior to said adjustment(s).
- 4 Parking Patron will purchase a parking access card for \$10.00 with an additional replacement fee of \$10.00 for each damaged, lost or stolen access card(s). These fees are not refundable should the Parking Patron cancel the parking agreement.
- 5 Parking Patron shall enter and use the parking facility at their sole risk, and Parking Patron hereby releases CCP and the owner of the parking facility from any claims relating to the condition of the Parking Facility. In addition, Parking Patron indemnifies CCP and the owner of the parking facility from any claims relating to any bodily injury, property damage, accident, fire or other casualty to or involving Parking Patron, its vehicle and/or other property in the parking facility. In all events, vehicles should be locked and valuables should not be left in the vehicle.
- 6 Parking Patron agrees to abide by any and all regulations pertaining to the use of the facility as may, from time to time be prescribed by CCP and further agrees to park where designated by CCP. Smoking is prohibited at all CCP parking facilities. Any violation of said regulations will result in immediate termination of parking right.
