- 1 City Creek Parking (CCP) grants to Parker the right to park one vehicle in one parking space in the specified parking facility upon availability (Parking Right), and will issue Parker one (1) parking access card (Card) for the Parking Right.
- 2 The Parking Right will become effective on the above date, and will remain active for two months from the last use of the debit card. If Parker fails to use the Card for a period of two months, the Card will be deactivated. Parker will pay \$5 as a reactivation fee to CCP to reactivate the Card. The term of this Agreement is month-to- month and CCP reserves the right to terminate the Parking Rights with thirty (30) days written notification.
- 3 Parker will pay \$10 for the cost of the card in addition to the cost of the Parking Rights credited to the Card. Parker assumes all risk of loss or damage to the Card, and CCP will not replace lost or stolen Cards nor refund the value of any balance remaining on the Card.
- 4 Parker agrees to pay CCP the amount set forth herein as a pre-paid amount for the Parking Right. The pre-paid amount shall be applied toward the charge for the use of the Parking Right. If the pre-paid amount is depleted, Parker will pay any outstanding charges at the parking exit gate. CCP reserves the right to adjust the hourly rate for the use of the Parking Right. CCP will use commercially reasonable efforts to notify Parkers of any rate adjustments. The Card shall be terminated one year after the last use of the Parking Right and Parker agrees that any unused amount on the Card at that time shall be forfeited. ***No refunds, credits or allowances will be granted for non-use of the Parking Right. ***
- 5 Parker authorizes CCP to deduct from the balance on the Card any charges that should have been charged to the Card (i.e., gate malfunctions, improper use of the Card, Parker circumvents the access system, etc.).
- 6 Neither CCP nor the property owners assume any responsibility whatsoever for loss or damage of the vehicle or its contents however caused, and Parker releases CCP and the property owners for any such loss or damage. Vehicles should be locked and valuables should not be left in the vehicle.
- 7 Parker agrees to abide by any and all regulations pertaining to the use of the facility as may, from time to time be prescribed by City Creek Parking or the Property Manager/Owner and further agrees to park where designated by City Creek Parking. Any violation of said regulations will result in immediate termination of parking right. Current rules and regulations can be found at www.citycreekparking.com
